Slovakian Plenipotentiary Urges U.S. Investigation into SARS-CoV-2 and mRNA Vaccines, Proposes Global Health Alliance

[WASHINGTON, D.C.] – Dr. Peter Kotlár, Slovakia’s Plenipotentiary for investigating the management of the coronavirus pandemic, has issued a formal letter to U.S. Secretary of Health and Human Services Robert F. Kennedy, Jr., calling for an immediate investigation into the funding, development, and release of the SARS-CoV-2 virus and the subsequent mRNA vaccines from Pfizer and Moderna. The letter, sent today, marks a significant international appeal for transparency and accountability in global health policy.

Dr. Kotlár, in collaboration with Richard M. Fleming, PhD, MD, JD, a key figure in COVID-19 research, has requested a high-level meeting with Kennedy to discuss the findings and explore a potential alliance between the U.S. and Slovakia to safeguard global health. The proposal comes amid growing international scrutiny of the origins of the pandemic and the safety of genetic vaccines.

Key Findings and Actions

Dr. Kotlár spearheaded an independent analysis of COVID-19 vaccine samples, conducted by Sona Pekova, MD, PhD, on behalf of the Slovakian government. The results, independently verified by Dr. Fleming, were presented to Slovakian President Peter Pellegrini and Attorney General Maroš Žilinka on March 13, 2025. The report alleges that SARS-CoV-2 resulted from laboratory manipulation and highlights an alarmingly high level of DNA material in Pfizer and Moderna vaccines—levels that exceed what might be attributed to mere contamination. These findings challenge existing narratives and demand further scrutiny.

In his letter, Kotlár urges Kennedy to initiate similar independent research in the U.S. to either corroborate or refute the Slovakian data. He emphasizes the need for a transparent, science-driven approach to protect public health worldwide.

Call for Collaboration

The proposed meeting between Kotlár, Kennedy, and Fleming aims to lay the groundwork for a new bilateral partnership. This alliance would focus on ensuring the integrity of medical research and fostering international cooperation to prevent future health crises. Context and Implications

The appeal aligns with a broader global conversation about the origins of SARS-CoV-2 and the safety of mRNA technology, with some voices questioning official accounts. While the Slovakian findings are yet to be independently validated by U.S. authorities, they have sparked debate and underscored the need for rigorous, unbiased investigation.
