I made a commitment to the government that by 31.3. 2025, I will carry out an analysis of the reference batches of vaccines used for the Slovak population against Cover 19, thus fulfilling my commitment. I will fully present the process, progress and results to the Government. I am ready to meet the deadline by 31.3. 2025 according to the terms of reference, because of the seriousness of the preliminary results and because of the suspicion of obstruction to carry out and present these analyses, I have decided to do so mainly for security reasons. For this press release, in the interest of protecting the health of the Slovak population, I publicly call on Attorney General Maroš Žilinka to act on the matter without delay. The 34 batches from Pfizer and Moderna up to this time that were stored according to the correct cold chain and only those that were used for the Slovak population at the time of the Cold XIX epidemic were analyzed.

Today I will present the most important result of the analysis. It can integrate into human nuclear DNA and then such a human organism becomes, I am not afraid to say officially, a genetically modified organism. A genetically modified organism is an organism whose genetic material has been deliberately altered. This is done, for example, on corn and in medicine.

It's in the research stage. So this is not about any contamination of vaccines, it is on purpose. A vast amount of genetic material that can transiently transform human nuclear DNA transparently, and this transaction can become stable and permanent. This transaction may with a sufficiently high probability influence tumor activity. They are tumor, they are spatial genes and cause tumor formation in cells that do not divide for example myocardium. Nerve cells cause such programming to oversensitize protons, the synthetic apparatus of the cell, and the cell perishes. They could also be used by the Supreme Audit Office and other branches of government for the purpose of developing a procedure for refusing to pay the amount ordered for the quantity of vaccines ordered by 2026.

It is your duty to inform the public of such serious findings. I think that is quite sufficient to unleash further analysis within the competence of informed states. It is an absolute scandal that disregards the knowledge of science and the rights of man. The integrity of the Slovak gene pool has been compromised. Thank you for your attention.
